1. Issues and ideas, as well as contemporary research findings in the field of economic education
2. Innovation in the field of pedagogy, curriculum, hardware, teaching materials, and methods & models in economic learning
3. evaluation of teaching methods, learning attitudes and interests, materials, or processes.
4. Reports on events that influence economic education in all levels of education age (from early childhood to adulthood) and three main lines of education, namely formal, nonformal, and informal.

## Peer Review Process

### Peer Review Process

The article submitted to **Jurnal Pendidikan Ekonomi Undiksha** will be reviewed by at least one reviewer and one peer-reviewer.

The decision made for the article is the result of the Editorial Board's agreement based on the suggestions proposed by the reviewer(s) and peer-reviewer(s).

In order to sustain the peer review system, authors have an obligation to participate in peer review process to evaluate manuscripts from others. When appropriate, authors are obliged to provide retractions and/or corrections of errors to the editors and the Publisher. All papers submitted to Jurnal Pendidikan Ekonomi (JPE) will be peer reviewed for at least one round. **Jurnal Pendidikan Ekonomi Undiksha** adopts a one-blinded review policy: authors are blind to reviewers, but reviewers are not blind to authors. The peer review process is conducted in the online manuscript submission and peer-review system. After a manuscript is submitted to the online system, the system immediately notifies the editorial office. After passing an initial quality check by the editorial office, the manuscript will be assigned to one or more reviewers. After receiving reviewers' comments, the editorial team member makes a decision. Because reviewers sometimes do not agree with each other, the final decision sent to the author may not exactly reflect recommendations by any of the reviewers.

The decision after each round of peer review may be one of the following:

1. Accept without any further changes.
2. Accept with minor revision. The revised manuscript may or may not be sent to the reviewers for another round of comments.
3. Decline with resubmission encouraged. Major changes are necessary for resubmission. The revised manuscript will be peer reviewed for another round. Typically, it will be sent to the original reviewers.
4. Decline without encouraging resubmission. The manuscript is rejected for publication by **Jurnal Pendidikan Ekonomi Undiksha**

These processes take a month for a maximum time. Plagiarism scanning will be conducted with the Anti-Plagiarism Software.

### **Publication decisions**

The editor is responsible for deciding which of the articles submitted to the journal should be published. ### **Fair play**

### **Duties of Reviewers**

#### **Contribution to Editorial Decisions**

Peer review assists the editor in making editorial decisions and through the editorial communications with the author may also assist the author in improving the paper.

The journal review using double blind review. Both reviewers will reviewed the same manuscript and the decision will be announced after all of reviewers give the evaluation.

#### **Promptness**

Any selected referee who feels unqualified to review the research reported in a manuscript or knows that its prompt review will be impossible should notify the editor and excuse himself from the review process.

#### **Confidentiality**

Any manuscripts received for review must be treated as confidential documents. They must not be shown to or discussed with others except as authorized by the editor.

#### **Standards of Objectivity**

Reviews should be conducted objectively. Personal criticism of the author is inappropriate. Referees should express their views clearly with supporting arguments.

#### **Acknowledgement of Sources**

Reviewers should identify relevant published work that has not been cited by the authors. Any statement that an observation, derivation, or argument had been previously reported should be accompanied by the relevant

citation. A reviewer should also call to the editor's attention any substantial similarity or overlap between the manuscript under consideration and any other published paper of which they have personal knowledge.

**Disclosure and Conflict of Interest**

Privileged information or ideas obtained through peer review must be kept confidential and not used for personal advantage. Reviewers should not consider manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or institutions connected to the papers.

**Duties of Authors****Reporting standards**

Authors of reports of original research should present an accurate account of the work performed as well as an objective discussion of its significance. Underlying data should be represented accurately in the paper. A paper should contain sufficient detail and references to permit others to replicate the work. Fraudulent or knowingly inaccurate statements constitute unethical behavior and are unacceptable.

**Originality and Plagiarism**

The authors should ensure that they have written entirely original works, and if the authors have used the work and/or words of others that this has been appropriately cited or quoted.

It is basically author's duty to only submit a manuscript that is free from plagiarism and academically malpractices. The editor, however, double checks each article before its publication. The first step is to check plagiarism against offline database developed by Jejak Research Centre and, secondly, against as much as possible online databases. Base on the online databases, the plagiarism percentage that allowed is no more than 20 percent.

**Multiple, Redundant or Concurrent Publication**

An author should not in general publish manuscripts describing essentially the same research in more than one journal or primary publication. Submitting the same manuscript to more than one journal concurrently constitutes unethical publishing behaviour and is unacceptable.

**Acknowledgement of Sources**

Proper acknowledgment of the work of others must always be given. Authors should cite publications that have been influential in determining the nature of the reported work.

**Authorship of the Paper**

Authorship should be limited to those who have made a significant contribution to the conception, design, execution, or interpretation of the reported study. All those who have made significant contributions should be listed as co-authors. Where there are others who have participated in certain substantive aspects of the research project, they should be acknowledged or listed as contributors.

The corresponding author should ensure that all appropriate co-authors and no inappropriate co-authors are included on the paper, and that all co-authors have seen and approved the final version of the paper and have agreed to its submission for publication.

**Disclosure and Conflicts of Interest**

All authors should disclose in their manuscript any financial or other substantive conflict of interest that might be construed to influence the results or interpretation of their manuscript. All sources of financial support for the project should be disclosed.

**Fundamental errors in published works**

When an author discovers a significant error or inaccuracy in his/her own published work, it is the author's obligation to promptly notify the journal editor or publisher and cooperate with the editor to retract or correct the paper.
